RESOLUTION

Visa exemption for citizens of: Federal Republic of Germany, the republic of France, The republic of Italy, the Kingdom of Spain, The United Kingdom and North Ireland, the Russia Federation, Japan, The Republic of Korea, the Kingdom of Denmark, the Kingdom of Sweden, the Kingdom of Norway, the republic of Finland and the republic of Belarus

THE GOVERNMENT

Pursuant to the Law on Government Organization dated on 19 June 2015; The Law amending and supplementing a number of articles of the Law on Government Organization and the Law on Organization of Local Government dated on 22 November 2019;

Pursuant to the Law on Immigration, Emigration, Transit and Residence of foreigners in Vietnam dated June 16, 2014; and amended code on the Law on Immigration, Emigration, transit and Residence of foreigners in Vietnam dated on 25/11/2019

Pursuant to Decree no 138/2016/NDD-CP dated on 01 October 2016 by the Government regulating the Government's working policy

Pursuant to vote by Government's members on proposal by the Minister of Foreign Affairs written in dispatch document no 463/BC-BNG-LS – m dated on 01 March 2022

DECIDES:

Article 1. To grant visa exemption to citizens from such countries: **Federal Republic of Germany, the republic of France, The republic of Italy, the Kingdom of Spain, The United Kingdom and North Ireland, the Russia Federation, Japan, The Republic of Korea, the Kingdom of Denmark, the Kingdom of Sweden, the Kingdom of Norway, the republic of Finland and the republic of Belarus upon immigration to Vietnam with the temporary resident period of 15 days from the entry date**, irrespective of passport types and immigration purposes, on the basis of fulfillment of regulatory requirements prescribed in Vietnam's laws.

Article 2. the policy of visa exemption to entry Vietnam for citizens mentioned in article 1 will be applied in 03 years, **started from 15 March 2022 till end of 14 March 2025**. This will be reviewed for renewal in accordance with the Vietnam laws

Article 3. The Resolution comes into effect from the date of signing and replaces for Resolution 21/NQ-CP dated 28/02/2020, No. 23/NQ-CP dated 02/03/2020, No. 29/NQ-CP dated 11/03/2020 and No. 33/NQ-CP dated 19/03/2020 by the Government on suspension of visa exemption.

Article 4: The Ministry of Foreign Affairs chairs to summarize, assess and propose to the Government on renewal, suspension or stop unilateral visa exemption in this Resolution.

Article 5: Minister, heads of ministerial-level agencies, heads of government-attached agencies, chairmen of People's Committees of provinces and centrally run cities, and relevant agencies are responsible for the implementation of this Resolution.
